The ECO Platform is a collaboration platform for programme operators in Europe, and its logotype is intended to act as a quality assurance of the member programmes. The logotype today symbolizes that the programme has successfully undergone an audit of its verification processes and practices to adhere to common quality rules..

### **Revised registrations fees from January 2015**
